# 18 May Item 1) Minutes of meeting held on 16th April 2021

#### 18 May Item 2) Matters arising from the Minutes

18/Feb/10 Tarbrax Christmas Lights - Update

Both suppliers provided by Councillor McClymont had been contacted and brochures received. Following discussion it became clear that the costs involved in either hiring or buying refurbished lights, and the annual recurring costs of installing and taking down the lights together with the costs of electricity outweighed the benefits of having the lights.

**It was agreed:** to abandon the matter and perhaps revisit the idea when maybe the refurbished lights then available would be LEDs and/or more affordable.

#### 18 May Item 3) Secretary's Report

- Report on actions from last meeting
  - Pothole reports have been submitted regarding: The stretch of road near Kilnpot Hall. The multiple strips across the C203 between Viewfield Farm and Woolfords Railway bridge. The Calla Rd near King's Inn (Agenda Item 7: Road repairs, closures and Potholes was taken together with

- The grant application to the WAT Group had been made and a grant of £1000 gratefully received towards the cost of the Great Get Together Fun Day.
- Edinburgh Bus service being withdrawn— Unable to find information. Seems that best information is from Biggar FB page. Alleen Campbell was seeking more information.
- Scottish Farmers 'Take a Lead Campaign' into Newsletter. This was not put into the Newsletter as there had been no room for it. However Scottish Farmers had been contacted who kindly sent out several posters which the Chairman put up in appropriate places.

## f) Working with WAT IF?

A summary of work being done in collaboration with WAT IF? was given:

- The secretary is on the WAT IF? Pathways Group as a private individual and updated the TCC on the Terms of Reference of that group for information.
- The suggested 'Roads' Steering Group was described. This is to be a small stand-alone group initially comprising the Secretary and Jemma from WAT IF?. It is intended to invite Carnwath CC and managers from the roads departments in SLC and West Lothian at a later date. The purpose is to improve communications and cooperation during periods of stress on the roads system during adverse weather and during road repairs/diversions. The group will convene during the summer.

# 18 May Item 4) Treasurers Report

- Balance £1417.63
- Grant of £1000.00. received from WAT Group towards cost of Great Get Together Fun Day.
- £2000.00 grant from WAT IF? used to pay marquee and inflatable hire directly, confirmation letter from WAT IF? to follow. (done like this because TCC don't have debit card facility or internet banking facility)
- Change of signatory forms: Another visit to RBS: Need a different form as well which requires signing by both previous signatories and then presentation with validated identification to an RBS branch (Carnwath branch now closed)

## 18 May Item 5) Tarbrax Village Hall

Feedback from TCC representative to TVHA

- SCIO Status: The application has been submitted to and its receipt been acknowledged by OSCR.
- AGM held on 15<sup>th</sup> May attended by TVHA members, TVH trustees and 4 members of the public 11 people in total. It was a satisfactory and positive meeting with a number of suggestions for income generation. There was also a suggestion to have an ATM installed in the Village Hall which needs further consideration and study. The Quiz night was well attended by groups who attend the event on a regular basis, however the Race night was not. The family group and those connected to the Hall who did attend the Race night had a very enjoyable evening.

#### 18 May Item 6) Community Council Elections 2021

- a) Timeline The form showing the timeline for the process was presented and discussed.
- b) Process Nomination forms will be provided at the June TCC Meeting. Details are on the website as are the Scheme Guidelines.

SLC will provide publicity and run the election – if an election is necessary.

- It may be necessary for the TCC to convene a meeting in August / early September to discuss arrangements such as publicity, leaflet drops, organisation required for CC election in October.

It was agreed: The August meeting of the TCC would take place as a full meeting to discuss the Community Council Elections and any organisation, publicity etc that we wished to do. (There is not usually a TCC meeting in August)

- c) Update Fauch Hill Windfarm Appeal PPA-400-2084 / LIVE/0235/FUL/17 informed 10<sup>th</sup> May of site visit.
- d) TCC Policy on planning applications for windfarms
- as discussed at last meeting we need to revisit and clarify the TCC policy. It is four years since the poll of residents resulted in a decision to oppose all windfarms. It was felt that a new survey is now needed to determine the current view of the residents as much may have changed. It was acknowledged that such applications are usually timed to coincide with public holidays when it was difficult to obtain residents opinions quickly by means of a public meeting.

After discussion it was agreed:

- 1) A further survey be carried out to obtain an up to date view of residents concerning windfarm development.
- 2) In the meantime, any applications for windfarm development would be addressed on a case by case basis with a public meeting being held if at all possible.
- The survey be carried out after the new Community Council was in place.

# 18 May Item 9) Great Get Together June 16th

#### 18 May Item 10) Litter Pick

- Woolfords have bought equipment (& done a litter pick) with a grant from the WAT group and they are happy to loan it out to other local groups. SLC will also provide equipment and uplift rubbish if they are informed when litter picks are taking place.

- There is a feeling that for the time being perhaps we should do our own areas or 'adopt' areas to do until something bigger can be organised for Tarbrax and other areas in conjunction with WAT IF? Perhaps after the Fun Day.

# Agreed: SM & MA would organise local litter picks around Tarbrax area in the meantime. Action: S.J.M. & M.A.

MA commented that dog fouling on the Common was becoming a major problem although it was clear that someone is cleaning it up.

The small roadside bin at the play Park in Auchengray is becoming a problem. The quantity of litter at the Small Bing was also commented upon.

#### 18 May Item 11) Items for Newsletter

The difficulty of items being submitted to the Newsletter and not being put in was brought up. It was explained that sometimes there is just too much material to fit in the Newsletter.
